

NOTICE OF CLAIM TO MINERAL RIGHTS

The undersigned, The Federal Land Bank of Saint Paul, a corporation formed under the laws of the United States, whose post office address is 346 Jackson St., St. Paul, Minnesota 55101, HEREBY GIVES NOTICE:

That it claims an interest in and to oil, gas, and other minerals in, on, or under the surface of the following described real estate in Dane County, Wisconsin.

That the instruments on which such claim is founded are duly recorded deeds of said lands executed by it wherein it reserved an ownership interest in and to oil, gas, and other minerals in, on, or under the surface of said described parcel(s) of land.
